Background

The Northern Territory Cattlemen's Association (NTCA) is the peak primary industry body of the Northern Territory. The NTCA provides representation to 90% of the Territory's cattle herd, and its members include small family owned and operated enterprises, large corporate holdings, and indigenous pastoral enterprises. NTCA members are custodians of over 700,000km², which equates to 45% of the Northern Territory's total land mass, and a cattle herd of approximately 2.1 million head.

The mission of the NTCA is to advance and protect the interests of cattle producers in the Northern Territory. Under the direction of an Executive Committee the NTCA works with all levels of government; federal, territory and local, as well as associated industries and relevant stakeholders to influence national and territory policy outcomes which ensure the long-term viability and future prosperity of NTCA members and the entire Northern Territory cattle industry.

The NTCA is a not-for-profit organisation, and is the only peak body representing Northern Territory cattle producers. Its strength and effectiveness as an organisation are directly attributable to the strong membership and financial support of the industry and its people.

Membership

In becoming a member of the NTCA you choose to affiliate with 1 or more branches (Central Aust, Barkly, Katherine, or Top End). If you have holdings in different locations, you will be allocated separate memberships. Each membership carries 1 vote in the branch in which it is located. Membership can be by way of "full" membership (where cattle numbers exceed 50 head) or "associate" membership, where an applicant may be in an associated business or industry or may not meet the minimum cattle numbers (associate members are not entitled to vote). Under the NTCA constitution membership applications are reviewed and approved by the NTCA Executive Committee.

Membership fees* (payable upon approval of application)

Full member subscriptions are calculated on number of branded head (x .35c) with a default minimum payment (\$700) and default maximum payment per membership (\$42,000); a membership with 2,000 head or less pays a minimum fee of \$700; a membership with more than 2,000 head pays .35c per head; a membership with more than 120,000 head pays the maximum fee of \$42,000.

Example 1

You have one holding in the Katherine region with 5,000 head:

- Your member number will start with K, e.g K7.
- Your subscription fee will be calculated as follows: 5,000 head x .35c = \$1,750 (+GST) payable.

Example 2

You have one holdings in the Katherine region each with 700 head:

- Your member number will start with K. Eg K7 and will cover both properties.
- Your subscription fees will be the minimum fee of \$700 because you have less than 2,000 head of cattle all together.

Example 3

You have two holdings, one in the Katherine region and one in the Alice Springs region, each with 10,000 head:

- You will be issued with two membership numbers, one starting with K, the other with A.
- Subscription fees are calculated as follows:
Katherine holding: 10,000 x .35c = \$3,500
Alice Springs holding: 10,000 x .35c = \$3,500
Total payable: \$7,000

Example 4

You have 6 holdings in Alice Springs region with a total of 200,000 head across all holdings:

- Your member number will start with A and will cover all 6 holdings.
- Your subscription fees will be the maximum fee of \$42,000 because you have more than 120,000 head in total.

*All amounts are ex GST and are valid until 31/12/2021.
